No one in your entry will be allowed to participate without these forms being submitted prior to the start of the parade.

NOTE: THE NORWEGIAN SEVENTEENTH OF MAY COMMITTEE reserves the right to reject or cancel any entry at any time should it be determined the entry detracts from the basic purpose of the Norwegian Seventeenth of May Celebration Parade and/or the viewing audience. Receipt of this form DOES NOT imply and/or guarantee acceptance into the Norwegian Seventeenth of May Celebration Parade.
